



Gateway Student Agreement Form:

- Each Gateway High School Student must present a completed copy of this Student Dance Agreement Form before purchasing tickets.
- If you are a Gateway High School student bringing a guest who is not enrolled at Gateway High School, please ensure that the Guest Agreement Forms are completed and submitted along with your forms -before purchasing tickets.
- Appropriate dress is mandatory for both boys and girls. All school dress code rules apply.
- Students will be searched at the door to the DoubleTree. No backpacks or bags. Small purses are permitted.
- No admission after 7:30 and no INS and OUTS.
- Students may leave at 9:30 and must exit the dance by 10:00.
- All dance tickets are nonrefundable.

If you are bringing a guest who does not attend Gateway High School:

- One guest ticket will be sold per Gateway student.
- Guest tickets may only be purchased at the time of the sponsor's ticket.
- All guests must enter the dance with their student sponsor.
- The Gateway High School student sponsor is responsible for their guest's behavior.
- NO MIDDLE SCHOOL STUDENTS OR GUESTS OVER 20 YEARS OF AGE.
- Guests must provide a copy of a valid state-issued ID attached or uploaded to their guest form. Guests will be required to present their ID to enter the dance.

In addition, a character verification must be emailed from an official email address from one of the following institutions:

The guest's current

- High School
- Post-Secondary Institution
- Employer
- Military Supervisor

- Non-participation list: Students with suspensions, multiple unexcused tardies, excessive unexcused absences, or administrative behavior concerns will be placed on the non-participation list per the student handbook or the administration's discretion. If you have reason to believe you are listed on the non-participation list, email ahurey@gatewayk12.org or cgiunta@gatewayk12.org before purchasing a ticket.
- If a student purchases a ticket and is listed on the non-participation list, there is no refund after purchase; this includes guest tickets, if one is purchased.

Administration's Right to Refuse Student Ticket Purchase and Entry:

This right may be exercised due to, but not limited to, concerns over safety, noncompliance with the School's policies and guidelines, or behavioral history. Such discretion will be employed judiciously to further the school's overriding interest in ensuring the safety and welfare of its student body and staff.

In addition:

The administration of Gateway High School expressly reserves the unilateral right to refuse the sale of guest tickets and/or deny admission to any guest at its sole discretion. The administration has the right to exclude individuals due to poor citizenship, age, or other reasons that, in the opinion of the administration, may jeopardize the event.
